Advancing Earth Science, Global Partnerships, and Career Opportunities

he NASA-ISRO Synthetic Aperture Radar (NISAR) mission, successfully on board GSLV F16 on July 30, 2025 at 1740 hrs IST from the Satish Dhawan Centre in Sriharikota Space India, represents a landmark in international space collaboration. This \$1.5 billion Earth-observing satellite, a joint endeavor between the National Aeronautics and Space (NASA) and the Administration Indian Space Research Organisation (ISRO), will revolutionise our understanding of Earth's dynamic systems. By employing advanced dual-frequency radar imaging, NISAR will provide unprecedented insights into natural processes, climate change, and disaster management. making it one of the most significant Earth-observation missions to date.

Such high-profile collaborations also serve as powerful engines of economic and human capital development, opening up new career avenues in aerospace engineering, remote sensing, Al-driven data analysis, climate

science, satellite operations, and geospatial entrepreneurship. As nations scale up investments in space infrastructure and innovation, missions like NISAR are expected to generate a wide spectrum of jobs—from scientific research and mission control to satellite manufacturing and space-tech startups— helping build a future-ready global space workforce.

India-US Space Collaboration: A Snapshot

India and the US share a longstanding space partnership, beginning with the Nike-Apache rocket launch in 1963 and evolving through key milestones like the US-built INSAT-1 satellites (1980s), NASA's instruments on Chandrayaan-1 (2008), and India's first astronaut to the ISS on the Axiom-4 mission (2025). India joined the Artemis Accords in 2023, further deepening ties, while private collaboration also grew with startups like Skyroot partnering with Axiom Space. NISAR mission, formalised in 2014, is the first joint hardware development between NASA and ISRO for Earth

observation, combining NASA's radar expertise and ISRO's satellite and launch capabilities— marking a new era in bilateral space cooperation.

What Makes NISAR Special

NISAR stands out as a groundbreaking Earth observation mission, combining the technological strengths of NASA and ISRO to deliver unprecedented data on our planet's dynamic systems. What makes it truly special is its dual-frequency radar system, the first of its kind to operate both L-band and S-band Synthetic Aperture Radars simultaneously, enabling deep penetration into vegetation, soil, and ice for detailed surface and subsurface monitoring. ndia's cooperative movement—steeped in the Gandhian ideal of self-reliance and shaped by more than a century of grassroots mobilisation— is entering a transformative new phase. No longer confined to the periphery of rural economies, cooperatives are being reimagined as dynamic, professionally-run institutions capable of driving inclusive development and employment generation.

The recent launch of the National Cooperative Policy 2025 and the foundation of India's first Cooperative

University—Tribhuwan Sahkari Vishwavidyalaya in Anand, Gujarat— mark a strategic recalibration of the cooperative ecosystem in line with India's aspiration of becoming Viksit Bharat @2047. This bold vision positions cooperatives not just as welfare vehicles but as robust engines of economic activity, entrepreneurship, and career opportunity— particularly for rural youth, women, and marginalised communities.

India's cooperative sector is immense home to over 8 lakh registered societies, more than 30 crore members, and

spanning areas from agricultural credit and dairy production to housing, textiles, fisheries, and processing industries. It connects directly with nearly one-third of the rural population and indirectly supports many more through downstream activities and allied services

Historically, these cooperatives evolved through decentralised, organic efforts, often fuelled by community spirit but lacking structured governance or professional skillsets. Consequently, while the sector achieved remarkable penetration, especially in rural India, it struggled to

modernise and scale sustainably in a changing economic and technological landscape.

Recognising this dual reality— of vast potential and structural limitations— the National Cooperative Policy 2025 has been formulated to infuse fresh vitality into the sector. It proposes to make cooperatives



The reserved vacancies will be filled up separately from amongst the eligible SCs, STs, OBCs, EWS candidates which will thus comprise of SC, ST, OBC (NCL), EWS who are either lower in merit than the last candidate on merit list of UR category or SC/ST/OBC (NCL) candidates who have availed age relaxation for respective category irrespective of their position in merit list. - 5. Method of Recruitment, By selection of ex-Naval apprentices (ex-apprentices of Yard Apprentice Schools of Indian Navy) and having age criteria as mentioned under the heading 'Age Limit' and 'Age Relaxation as on the Crucial Date'. The candidate should be in possession of Apprenticeship Certificate of respective trade issued by either National Council of Vocational Training or a Naval Yard Apprentice School depicting marks.
- Nature of Duties/Job Profile in Brief. The Tradesman Skilled as per his/ her trade is required to undertake repairs of equipment/ structures and refit of ships and submarines and shall work both onboard ships/ submarines and at the shop floor. The trade wise nature of duties/job profile is elaborated below: -
- (a) <u>Auxillary.</u> Drive commercial vehicles, tractors, lister, platform trucks, fork lifts and mobile cranes. Also responsible for working on a mobile crane and equipment including lifting, lowering and slewing and traversing.
- (b) <u>Civil Works</u>. Maintenance of buildings, roads, gardens, fountains, jetties, docks and wharves in the Yard. Also to undertake collection and disposal of dry/ wet garbage and debris and maintenance of sewage system of the Yard.
- (c) Electrical. Rewinding of all electrical rotary machineries including generators, converters, motors, armatures, transformers etc. Also responsible for repairs in shop floor and in-situ of stators, rotors, armatures, dynamos, igniters, tacho generators DC motors etc. Also required to undertake electroplating activities viz. Hard chrome, nickel, copper, tin, zinc and lead plating. Commissioning and capacity test of different types of low power batteries, loading/unloading of main propulsion batteries of submarines.
- (d) Electronics & Gyro. Undertake repairs of PCB integrated circuits, modules and whole assemblies, control and stabilisation systems of navigations systems, weapons and their associated systems and coding. Repairs, maintenance, installation and trials of gyro, ring laser gyros, Fibre optic gyros and magnetic compass onboard ships and submarines. Repair, calibration and refitting of various instruments, actuators, relays, switches, timer circuits, sensors, PCBs etc. and armament alignment, installation, setting to work and trials of control system of weapon equipment onboard ships and submarines. Also responsible for installation and commissioning of new generation navigation and weapon equipment onboard ships and submarines.
- (e) Foundry. Construct and work on various types of cores, patterns, moulds and fettling operations. Work on wood working machinery and in foundry. Also work on casting operations and rectify defects arising on casts. Work on various furnaces and able to rectify defects occurring during cupola operations.
- (f) Heat Engine. Repair/ overhaul, installation, setting to work and trials of main diesel engines, gas turbines, reduction gears, diesel alternators and gas turbine generators onboard ships and submarines including lowering, foundation preparation, mounts grouping and alignment. Fitment of all auxiliary machinery, fittings and associated systems related to diesel engines and gas turbines onboard ships. Also undertake capital repairs and routines of various types of diesel engines, gas turbines, diesel alternators, gas turbine generators and reduction gears fitted onboard ships and submarines.
- (e) Instrument. Work on control systems of power and electrical systems onboard ships and submarines. Responsible for switchboard control systems, signal conditioning, data acquisition and conversions and measurement of power.
- (f) Machine, Work on Lathe, Milling, Grinding, Drilling, Boring, Shaping and all general workshop machines. Usage of special machine tools related to the trade such as automatic lathe, multi-spindle lathe, crank turning lathe etc. Usage of advanced machines such as 3 axis, 5 axis CNC machines, reclamation of worn out components of machinery by metal deposition and other methods, heat treatment of steels, manufacture of special tools, jigs and fixtures and Die making materials and metrology related works.
- (9) Mechanical, Repair/ overhaul, installation and trials of main propulsion machinery, auxiliary machinery, governors, deck machinery, flight deck machinery, light gun mountings, launchers, torpedo tubes and mine laying equipment of ships and submarines etc. Also work on alignment of all types of machinery, underwater valves and fittings, chemical cleaning of machinery parts, reclaiming of worn out machinery parts and extraction and fitting of equipment onboard ships and submarines. Installation of new gun mountings and launchers onboard ships and submarines.
 - Mechanical Systems, Manufacture of pipes and associated fittings of various shapes and sizes using different materials and their fitment onboard ships and submarines, chemical cleaning of pipes, annealing, hardening and burning of pipes, hot and cold bending of pipes, gauging and templating of pipes, manufacture and fabrication of various joints and fittings used for completing pipe systems, repair of valves of various sizes and shapes and of various materials, survey, fabrication, testing and inspection of various systems onboard. Removal and refitting of boilers, super heaters and economisers and associated fittings onboard ships. Undertaking of boiler expansion arrangements, refractory brickwork, welding of boiler pressure parts, bending and setting of tubes as per templates, fabrication and working with jigs and fixtures, hot insulation used for boilers fittings and equipment and maintenance of registers and records. Lagging/ relagging of main and auxiliary equipment and all systems onboard ships and submarines.

- (j) Mechatronics. Repair/ overhaul, installation and setting to work and trials of hydraulic, pneumatic and electronic control systems relating to steam propulsion plants, boiler combustion control system, diesel main engines, diesel alternators, gas turbines, gas turbine generators, steering and stabiliser systems, winch control systems, lub oil and fuel tank level control systems etc. Repair and refit control equipment used in hydraulic, pneumatic and electronic control systems. Repair, calibration and refitting of various instruments, actuators, relays, switches, timer circuits, sensors, PCBs etc.
- Metal. Welding, brazing, soldering, metallizing onboard ships and submarines. (k) Undertake different types of welding like MIG, TIG, metal arc, submerged arc, ultrasonic etc. onboard vessels, welding of joints and rectify defects in welding, Undertake cutting of plates, sheets and other ferrous and non-ferrous metals onboard ships and in the shop floor utilising oxy-acetylene, LPG, plasma and ultrahigh pressure water cutting by the use of automatic and semi-automatic procedures and non-destructive testing of weld joints by the use of various methods. Also undertake Plate preparation, priming and marking, riveting work, development of shell plates having curvature in one or two directions, cold and hot bending of steel plates and sections, lifting/handling of a prefabricated panel hull survey, testing of compartments and tanks for water and air tightness, Air pressure test and Citadel trials etc. All types of sheet metal processes undertaken in the Yard, development of shell plates having curvature in one or two directions, cold and hot bending of steel plates and sections, joining of sheet metals riveting, spot welding, soldering, etc., various types of paneling required to be fabricated and fitted onboard ships and submarines, paneling in cold room/cool room and inside GT intakes. Undertake repair, overhaul and maintenance of ships and submarine services relating to Freshwater, sanitary, pump, flooding and draining arrangements and other fitted systems. Also to repair rod gearing and various types of valves used in systems and service various doors, hatches, scuttles, manholes, ventilation flaps and other associated arrangements. Undertake repairs of various appliances like gantry, davits, derricks etc. used in ships and submarines, aircraft lifts, telescopic and rolling shutters and dome operating mechanisms and their associated systems. Survey and repairs of anchor and chain cable, load testing of chain cables, heat treatment of various fittings and accessories associated with anchor and anchor chain cables, examination & test of wrought iron chain cable and forged steel chain cable.
- (I) Millwright. Lathe, milling, boring, drilling and grinding operations and maintencance. Repair and overhaul of machines, installation and erection of foundation of machines.
- (m) Refrigeration & Air Conditioning. Overhaul and repairs of different types of air conditioning and refrigeration plants. Undertake pressure test, vacuum test, charging and trial of plants. Testing, maintenance and servicing of Ref & AC Plants excluding electrical side. Calibration and testing of all instrumentation and cut outs/ alarms used on the Plants. Undertake chemical cleaning of coils, condenser shells, ATUs etc. in shop floor. Overhaul sealed unit compressor and domestic refrigeration and A/C machines.
- (n) Ship Building. Operation of caissons, dock gates etc., laying wooden docks, deck planking, repair and erection of keel blocks, cradles, shoring, cribbing and other structures used for supporting ships in dry docks, lamination and bending of wood for fabrication of large sections, manufacture of catamarans, rafts, floats, pontoons, masts, spares, ladders etc. and work on wood working machines and portable tools. Also repair hull of all types of GRP boats, collar plates, and associated fittings and carry out leak checks. Work with rigging material whilst docking/ undocking of vessels, berthing and warping of ships. Application of underwater anti corrosive paints, anti-fouling paints, boot topping and all types of primers and various types of paints and colour schemes onboard ships and submarines. Servicing and routines on the fabric portion of all lifesaving equipment. Execution of detailed test procedure on completion of every repair and servicing job of life saving equipment and packing of all type of life rafts as per SOLAS regulations.
- (p) Weapon Electronics. Repair, maintenance, installation and setting to work and trials of all radar systems, transmitters, antennas, displays, communication systems, sonars, logs, echo sounders, underwater telephones and other systems including their PCBs, modules etc. fitted onboard ships and submarines. Also responsible for repairs and overhaul of all underwater systems, associated hull-outfits, winches, towed arrays.
- Note. The duties indicated here are only illustrative and not exhaustive. User Department of Indian Navy may add in the list, duties ordinarily performed by personnel of this level.

- (d) <u>Syllabus for Examination.</u> The indicative syllabus for subject recruitment is as follows:
- (i) General Intelligence and Reasoning. This section would include questions of both verbal and non-verbal type. It would include questions on analogies, similarities and differences, space visualization, problems solving, analysis, judgment, decision making, visual memory, discriminating observation, relation concepts, figure classification, arithmetical number series, non-verbal series etc. The section will also include questions designed to test candidate's ability to deal with the abstract ideas, symbols and their relationship, arithmetical computation and other analytical functions.
- (ii) General Awareness. Questions are designed to test the general awareness of the environment and its application to the society. Questions will also be designed to test knowledge of current events and of such matter of everyday observation and experience in their scientific aspects as may be expected of any educated person. 
